Some Basic Concepts

- IF a principal avenue for developing countries to improve living standards is to attract foreign private investment
- AND for many countries, including some of the poorest, natural resource investment is the main kind of investment they may initially be able to attract;
- THEN the terms on which that investment is made need to facilitate sustainable forms of development.
- **IN SHORT**, the investment bargain has to work for both the host country and the foreign investor. It is both a commercial transaction and a profoundly important public decision.

Some Limitations

- NO ONE thinks that a contract text on its own, no matter how well done, is alone enough to get us on the path of sustainable development. It is at best one of a number of elements that are needed for success.
- CIRCUMSTANCES VARY, requiring that a model contract contain a variety of options for resolving the most important issues.
- Many of us believe that a good mining development agreement needs to be preceded by and somehow linked to a good EXPLORATION AGREEMENT.
- And that an agreement between investor and host country needs to be accompanied by and somehow linked to an agreement at the local level – a COMMUNITY DEVELOPMENT AGREEMENT.

Where Process is Going

- STAGE ONE: Consultation in March, 2010 in Toronto. A meeting principally intended to attract government participation over 100 attendees.
- STAGE TWO: Consultation in April, 2010 in Toronto. This meeting, primarily aimed at civil society and academic participants.
- STAGE THREE: Consultation Website Launched by May 3. Interactive website that will allow anyone to follow the Model Agreement as it emerges, and comment for attribution or anonymously.
- STAGE FOUR: We Seek Your Suggestions. How can the consultation be most effective over the next several months?
- STAGE FIVE: October, 2010: MMDA presented to IBA Annual meeting in Vancouver

PROPOSED METHOD OF WORK

- The Mining Law Committee has established a Working Group that will manage the drafting process, which will be done by a number of volunteer members.
- The work starts from a base of existing agreements, such as the three you have been sent;
- The objective is to produce a web based product, available to all, with multiple alternative clauses for key points.
- Our intent is that this development take place in a highly transparent environment with an effective process of consultation.



BEYOND OUR PROJECT

- This is a 'hot topic.' There are many organizations interested in this topic and in this project.
- There is an ongoing project focusing on African mining agreements. ECA/AU International Study Group is producing a Framework Report on the Review of Africa's Mining Regimes; review meeting planned for September 2010. Contact Wilfred Lombe, wlombe@uneca.org
- There is also a process called the Fair Mineral Development Initiative of the World Economic Forum, which kicks off in June in Ulan Bataar.
- There is a related ICMM effort starting in October of this year.
- While we want to maintain communication with these other projects, there are no 'links' beyond that between the IBA project and these other efforts.
